Just want to give the RIPA members an update on the landing/handling fees at MVY. I have been in contact with the FAA NE Airports division, and have filed an informal complaint alleging that their fees discriminate against multi-engine aircraft because they charge ZERO fee for a single-engine aircraft to land/park for a day, and upwards of \$53 for a multi-engine to stop for breakfast or lunch. My most recent letter has been sent by the FAA to the MVY airport manager for comment.

I have also been in contact with Woody Cahall, the VP of Government Affairs at AOPA, and although AOPA has been largely silent on this issue, they recognize that it is becoming an important issue for pilots, and offered to send a follow-up letter to the FAA. Stay tuned, because the battle is sure to heat up. If you don't think it will affect single-engine pilots, it's just a matter of time before airport start charging single-engine planes the exorbitant fees that some airports are charging. For example, I was planning a trip to Baltimore last week, and the Signature FBO who has a monopoly there wanted to charge a \$150 "handling fee" on top of a \$25 landing fee and \$18 parking fee.

Your assistant called me yesterday and informed me that you received my emails and are working on the AOPA support letter for MVY. Thanks!

Just as an FYI, I was planning a trip to Baltimore this week in my 1973 C421B, but had to cancel at the last minute due to a maintenance issue. I called Signature, the FBO there to get an idea of the fees ... this is beautiful. They wanted to charge me a \$150 "handling fee" on top of the \$25 landing fee, plus a \$18 parking

fee if I stay more than 3 hours (the landing and handling fees don't come with a place to park!). Of course, they would "waive" the handling fee if I bought 50 gallons of 100LL at \$7.13/gallon – which is almost exactly \$3.00 ABOVE what I normally pay. So they are going to get their \$150 whether I buy gas or not. This is nothing more than extortion. What happened to the "fair and reasonable fees" associated with this public-use airport?

We talked about this, but my feeling is that we need regulation REQUIRING public-use airports to provide airport access to GA pilots, either through the FBO or a GA terminal, regardless of whether they buy fuel or not. A pilot should be able to refuse FBO services if he/she doesn't need them or if they are overpriced. As it stands now, the FBOs at many airports (MVY, ACK, PVD, BAL, TEB, IAD, etc.) are controlling the security gates, and using that to extort unreasonable sums of money from GA pilots. Corporate aircraft (Netjets, etc.) can negotiate lower fuel rates based on volume, and typically get these fees waived. You might say "well don't go to that airport if you don't want to pay". But the argument is that we pilots have a right to use all public-use airports, and shouldn't have to pay these unreasonable fees just because the FBOs are controlling the security gates. And there is no other justification for the fees other than greed and because we let them get away with it.

I checked the Southwest.com website, and I can buy a round-trip airline ticket from PVD-BWI for less than the total fees charged by Signature to land/park my C421 at BWI. If nothing else, these unreasonable fees discourage pilots from legitimate business and personal use of high-performance multi-engine aircraft.

Thanks for the additional input Bill. There have always been a few price gougers that either priced themselves out of business or competition forced normalization after a short time. The last 18 months have been different. Unreasonably high prices are becoming the norm, FAA has done little to stabilize the trend and the developing culture of handling large aircraft only and diverting other aircraft through an exorbitant pricing scheme is becoming widespread.

Members have been all to clear in letting us know the situation this year as we raised awareness of the user fee issue. We might escape user fees for now - but to little avail if we can't afford to land.

Dealing with this trend is a tactical objective for 08 but with little to nothing in rule or law, it will be difficult.
